

**FY 2023/2024 RENEWAL AGREEMENT BETWEEN THE
CITY OF HAINES CITY AND JENNINGS KEMP BRINSON
FOR SPECIAL MASTER SERVICES**

This Agreement is entered into this _____ day of _____, 2023, by and between the CITY OF HAINES CITY, FLORIDA (“City”), located at 620 E. Main St., Haines City, Florida 33844, and JENNINGS KEMP BRINSON (“Special Master”), located at Reed Mawhinney & Link, 53 Lake Morton Dr., Ste 100, Lakeland, Florida 33801.

WHEREAS, the Special Master and the City entered into an Agreement Between the City of Haines City and Jennings Kemp Brinson for Special Master Services on or about November 18, 2021 (the “Special Master Agreement”);

WHEREAS, the Special Master Agreement provides that, after fiscal year ending 2022, the Special Master Agreement could be renewed for five additional one-year periods, i.e., through fiscal year ending 2027;

WHEREAS, the Special Master Agreement was renewed pursuant to a FY 2022/2023 Renewal Agreement on or about June 15, 2021, effective until the end of the City’s 2023 fiscal year (September 30, 2023);

WHEREAS, the Special Master Agreement provides that, for renewal periods, the Special Master and the City shall agree on a fee schedule;

WHEREAS, since September 30, 2023, the Special Master and the City have continued to maintain their relationship, without an additional formal renewal; and

WHEREAS, the Special Master and the City desire to again formally renew the Special Master Agreement;

NOW THEREFORE, the parties hereby amend and renew the Special Master Agreement pursuant to the following terms and conditions:

1. The foregoing recitals are true and correct.
2. Pursuant to paragraph 1 of the Special Master Agreement, the Special Master Agreement is hereby renewed for a period of one year, fiscal year 2023/2024, effective *nunc pro tunc* October 1, 2023, and continuing through and including September 30, 2024.
3. The fee schedule for the Special Master for fiscal year 2023/2024 shall be a rate of \$176.31 per hour¹.
4. Except as explicitly set forth herein, the Special Master Agreement remains in full force and effect.
