EMPLOYEE PARKING/LDR SEC. 11.1.6:

WHERE OFF-STREET PARKING FACILITIES ARE SPECIFIED ON THE BASIS OF NUMBER OF EMPLOYEES, SUCH PARKING SHALL BE CLEARLY MARKED AND RESERVED FOR USE OF SUCH EMPLOYEES. WHERE A USE IS REQUIRED TO PROVIDE AND RESERVE A CERTAIN NUMBER OF SPACES FOR EMPLOYEES AND THE NUMBER OF EMPLOYEES INCREASE AFTER THE BUILDING IS OCCUPIED. THEN THE AMOUNT OF OFF-STREET PARKING PROVIDED SHALL BE INCREASED IN RATION TO THE INCREASE IN THE NUMBER OF EMPLOYEES. PLANS SUBMITTED SHALL MAKE PROVISION FOR PROJECTED FULL OR PEAK EMPLOYMENT.

ILW OUTDOOR (5):

OUTDOOR STORAGE YARDS AND LOTS, PROVIDED SUCH OUTDOOR STORAGE/LDR SEC. 5.6.17 (B) STORAGE YARD SHALL NOT BE LOCATED CLOSER THAN 25 FEET TO ANY PUBLIC STREET AND THAT SUCH YARD SHALL BE COMPLETELY ENCLOSED, EXCEPT FOR NECESSARY INGRESS AND EGRESS, AND HAVE A SOLID FENCE OR WALL NOT LESS THAN SIX FEET HIGH AND PROVIDED FURTHER THAT THIS PROVISION SHALL NOT PERMIT WRECKING YARDS (INCLUDING AUTOMOBILE WRECKING OR SALVAGE YARDS), JUNK YARDS, OR YARDS USED IN WHOLE OR IN PART FOR SCRAP OR SALVAGE OPERATIONS OR FOR PROCESSING STORAGE, DISPLAY OR SALES OF ANY SCRAP, SALVAGE, OR SECONDHAND BUILDING MATERIALS, JUNK AUTOMOTIVE VEHICLES, OR SECONDHAND AUTOMOTIVE VEHICLE PARTS.

OFF STREET PARKING APPLICATION/KDR SEC.11.1.2:

OFF-STREET PARKING FACILITIES SHALL BE PROVIDED AS REQUIRED BY THIS CHAPTER, FOR PURPOSES OF THIS CHAPTER, AN OFF-STREET PARKING SPACE SHALL CONSIST OF A SPACE ADEQUATE FOR PARKING A STANDARD SIZE AUTOMOBILE WITH ROOM FOR OPENING DOORS ON BOTH SIDES, TOGETHER WITH PROPERLY RELATED ACCESS TO A PUBLIC STREET OR ALLEY AND MANEUVERING ROOM. REQUIRED OFF-STREET PARKING AREAS FOR THREE OR MORE AUTOMOBILES SHALL HAVE INDIVIDUAL SPACES MARKED, EXCEPT AS PROVIDED BELOW, AND SHALL BE SO DESIGNED, MAINTAINED AND REGULATED THAT NO PARKING OR MANEUVERING INCIDENTAL TO PARKING SHALL BE ON ANY PUBLIC STREET, WALK OR ALLEY, AND IN SUCH A MANNER THAT ANY AUTOMOBILE MAY BE PARKED AND UN-PARKED WITHOUT MOVING ANOTHER.

OUTDOOR PAVEMENT REOUIREMENTS/LDR SEC. 11.1.2 (C):

EXCEPT AS PROVIDED BELOW, ALL OFF-STREET PARKING SPACES. LOADING AREAS, STORAGE AND RELATED ACCESS AREAS SHALL BE CONSTRUCTED IN ACCORDANCE WITH CHAPTER 13 OF THE LDR SITE COMPATIBILITY REQUIREMENTS/LDR SEC. 5.2.18:

CONSTRUCTION REQUIREMENTS FOR MINOR STREETS AND MAINTAINED IN A MANNER PERMITTING SAFE AND CONVENIENT USE, AND SO AS TO AVOID ADVERSE EFFECTS ON NEIGHBORING PROPERTY AS A RESULT OF DUST OR DRAINAGE

IN ORDER TO PROMOTE SAFETY, IMPROVE TRAFFIC CIRCULATION ON AND AROUND A SITE AND TO PREVENT POTENTIAL ADVERSE EFFECTS, PETITIONERS FOR ALL RESIDENTIAL, INSTITUTIONAL, COMMERCIAL AND INDUSTRIAL DEVELOPMENT ACTIVITIES, EXCEPT AS PROVIDED OTHERWISE WITHIN THE LDR, SHALL SUBMIT A SITE PLAN MEETING THE REQUIREMENTS AS STATED IN CHAPTER 5 OF THE ADMINISTRATION AND PROCEDURES MANUAL. THE SITE PLAN SHALL BE SUBMITTED FOR REVIEW TO THE ADMINISTRATIVE OFFICIAL INDICATING PROPOSED USES AND STRUCTURES, DRIVEWAYS AND PARKING AREAS, MINIMUM REQUIRED YARDS, BUFFERING, SIGNS, LANDSCAPING, DRAINAGE AND SUCH OTHER DETAILS AS ARE REQUIRED BY THESE SECTIONS BY GENERAL RULE OR IN THE PARTICULAR CIRCUMSTANCES OF THE CASE, AND SHALL INDICATE A SCHEDULE FOR INITIATION AND COMPLETION OF DEVELOPMENT.

IF APPROVED, THE SITE PLAN SHALL BE BINDING UPON THE PETITIONERS AND ANY SUCCESSORS IN TITLE, AND NO SUBSTANTIAL CHANGE SHALL BE PERMITTED WITHOUT APPROVAL FROM THE ADMINISTRATIVE OFFICIAL.
