- 3. Respondent has not complied with the Findings of Fact, Conclusions of Law and Order.
- 4. It is hereby Ordered that Respondent pay to the Petitioner CITY OF HAINES CITY, FLORIDA, a fine in the amount of <u>136.16</u> which includes administrative costs of <u>36.16</u> and for the fine proven hereinabove and which shall continue in the amount of <u>100.00</u> per day for each and every day until the city issues an Affidavit of Compliance and Notice of Termination of Daily Fine. A certified copy of this Order may be recorded and once recorded shall constitute a lien against the above-described property and all other real and personal property owned by the Respondent, pursuant to Florida Statutes, Chapter 162.
