THIRD AMENDMENT TO PROFESSIONAL CONTINUING SERVICES AGREEMENT

THIS THIRD AMENDMENT TO PROFESSIONAL CONTINUING SERVICES AGREEMENT (the "Third Amendment") is made as of this _____ day of _____, 2022, and constitutes the amended agreement between VANASSEE HANGEN BRUSTLIN, INC., (hereinafter referred to as "VHB"), a Florida corporation located at 501 E. Kennedy Blvd., Suite 1010, Tampa, FL 33602 and the CITY OF HAINES CITY, FLORIDA, a Florida municipal corporation ("CITY"), located at 620 East Main Street, Haines City, Florida 33844.

RECITALS:

WHEREAS, VHB and CITY entered into that certain Professional Continuing Services Agreement ("Agreement") dated July 20, 2017 (the "Agreement");

WHEREAS, the initial term of the Agreement was for a three (3) year period which concluded on July 20, 2020 and the Agreement was subsequently extended through July 20, 2022 by two amendments to the Agreement; and

WHEREAS, the parties have agreed to amend the Agreement by entering into the Third Amendment.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- 1. **Recitals.** The Recitals set forth above are true and correct and are incorporated herein by reference.
- 2. **<u>Defined Terms.</u>** Except as specified to the contrary in this Amendment, all defined terms in this Third Amendment have the same meaning set forth in the Agreement.
- 3. <u>Extension of Term</u>. The term of the Professional Continuing Services Agreement is hereby extended for an additional one-year term beginning on July 20, 2022 through July 20, 2023.
- 4. <u>Conflict</u>. If there is a conflict between the terms of the Agreement and this Third Amendment, the terms of this Third Amendment shall control.
- 5. **Ratification.** Except as herein expressly amended, each and every other term of the Agreement shall remain unchanged and in full force and effect without modification, and the parties hereby ratify and affirm the same.

6. <u>Counterparts.</u> This Third Amendment may be executed in several counterparts, all of which are identical and all of which counterparts together shall constitute one and the same document. This Third Amendment may be executed by facsimile signature.
